

Full-Time Courses

- **If your home is in Scotland**, your tuition fees are normally paid by the Students Awards Agency for Scotland (SAAS) and you can apply for a student loan to help you with your living expenses. For full details visit www.saas.gov.uk
- If you are classed as being ordinarily resident in **England, Wales or Northern Ireland** you will be required to pay **tuition fees** for each year of your course. Please visit the undernoted www.gov.uk/student-finance if you live in England

Part-Time Courses

Normally you are responsible for your course fees. However, in some circumstances it may be possible to receive help towards the cost of your part-time study as indicated below:

SAAS Part Time Fee Grant

It may be possible to use funding from a SAAS Part-Time fee Grant (PTFG) to pay for or contribute towards course fees. In order to be eligible individuals must be over 16, ordinarily resident in Scotland, earning less than £25,000 per year, studying a part-time Higher Education course (e.g. HNC and above) at levels 7-10 of the Scottish Credit Qualifications Framework (SCQF) and completing between 30-119 SCQF credits per academic year and not receiving support from any other government scheme.

Employment

If students are in employment, their employer may be willing to sponsor them and contribute towards their fees.

Self-Funding

Students who pay for their own course fees will be issued with an invoice for the full course fee at the point of enrolment or as soon as possible thereafter.

Payment of Fees

The payment of fees is the responsibility of the student. In the event of a student's sponsoring authority (eg SAAS, employer or other funder or a parent or guardian) failing to make payment, the student will be held personally liable for payment. Postgraduate Funding

Eligible full time Scottish domiciled students can access tuition fee loans up to £7,000 from Student Awards Agency for Scotland (SAAS). If the total tuition fee charge is higher than the total £7,000, the student must pay the difference, and if it is less, the student will only be allowed to borrow the actual amount of the tuition fee.

Part-time students are eligible to receive the fee loan element only which would be paid to the academic institution over two years. Part time students are not eligible for living cost loans.

SAAS will provide tuition fee loans, living cost loans and DSA support for eligible students undertaking eligible Research Masters courses. See the following for further details:

For postgraduate taught students in receipt of SAAS tuition fee loans, tuition fees will be paid directly to the university. If a student withdraws from their course, they may still be liable for the repayment of the loan depending on their start date and when they left the programme. Please refer to the fee policy:

Student Support – Discretionary and Childcare Funds

HE Discretionary Fund

The fund is intended to provide financial help to students whose access to or continuance in higher education may be inhibited by financial considerations. It can be used to assist to fund accommodation, travel, living costs, etc for students who can demonstrate that they are in genuine hardship.

HE Childcare Fund

This fund is for childcare only. The childcare must be registered.
